

Website Terms of Use

Acceptance of the Terms of Use

These terms of use are entered into by and between you and Claritas, LLC (**Company**", "we" or "us"). The following terms and conditions, together with any documents they expressly incorporate by reference, including the **Privacy Policy**, (collectively, these "**Terms of Use**"), govern your access to and use of Claritas.com, including any content, functionality, and services offered on or through Claritas.com (the "**Website**"), whether as a guest or a registered user.

Limitation on Time to File Claims
